

ORDINANCE NO. O2019-04

AN ORDINANCE AMENDING CHAPTER NO. 925.07(b), (1)(A) AND (2)(A), SEWERS, RATES, SEWER SERVICE CHARGES (INSIDE CITY AND OUTSIDE CITY), OF THE CODIFIED ORDINANCES OF THE CITY OF GALLIPOLIS, OHIO

WHEREAS, the City of Gallipolis, Ohio wishes to increase the rates for sewer usage to compensate for increased costs.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, Ohio:

Section 1. That Section 925.07(b) Sewer Service Charges, which reads as follows:

925.07 RATES

(b) Sewer Service Charges. The following are hereby fixed as the fair, proportional and reasonable rates for sewer service charges and user charges based on the metered consumption of water. All users discharging waste to the sewage collection system shall be billed for wastewater treatment services including governmental or institutional users such as schools, municipal utilities or other public buildings.

(1) Sewer service charges – inside City. The metered rates for users of sewer inside the corporation limits shall be billed per hundred gallons and read to the nearest hundred gallons.

A. The metered rates inside the corporation limits shall be as follows effective at the earliest period of time permitted by law:

(2) Sewer service charges – outside City. The metered rates for users of sewer outside the corporation limits shall be billed per hundred gallons and read to the nearest hundred gallons.

BE, AND HEREBY IS, AMENDED to read as follows:

925.07 RATES

(b) Sewer Service Charges. The following are hereby fixed as the fair, proportional and reasonable rates for sewer service charges and user charges based on the metered consumption of water. All users discharging waste to the sewage collection system shall be billed for wastewater treatment services including governmental or institutional users such as schools, municipal utilities or other public buildings.

(1) Sewer service charges – inside City. The metered rates for users of sewer inside the corporation limits shall be billed per hundred gallons and read to the nearest hundred gallons.
