

ORDINANCE NO. O2020-30
**AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING THE CITY
MANAGER TO ENTER INTO A FINAL AGREEMENT WITH THE STATE OF OHIO
FOR THE STATE ROUTE 588 SLIP REPAIR**

WHEREAS, State Route 588 within the Village of the City of Gallipolis is in need of repair due to a landslide; and

WHEREAS, the City Manager entered into an agreement with the Director of Transportation proposing cooperation with the Director of Transportation for the described project; **The project consists of a landslide repair by drilled shaft retaining wall along S.R. 588 located 150 feet east of Chillicothe Road, including pavement repair and pavement markings, lying within the Village of the City of Gallipolis;** and

WHEREAS, the City Manager further agreed to cooperate with the Director of Transportation in the above described project as follows: **The Village agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the City limits, less the amount of Federal Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.**

The share of the cost of the Village is now estimated in the amount of **Eight Thousand Five Hundred Eight and - - - 80/100 Dollars, (\$8,508.80)**, but said estimated amount is to be adjusted in order that the Village's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, the above stated preliminary legislation was set forth in Ordinance No. O2019-28 adopted September 3, 2019, and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The Village desires the Director of Transportation to proceed with the aforesaid highway improvement.

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW THEREFORE, be it ordained by the Village of the City of Gallipolis, of Gallia County, Ohio:

- I. That the estimated sum of **Eight Thousand Five Hundred Eight and - - - 80/100 Dollars, (\$8,508.80)**, is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from **Federal** funds.
- II. That the Village hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.
- III. That the Village enter into a contract with the State, and that the **City Manager** be, and is hereby authorized to execute said contract, providing for the payment of the Village the sum of money set forth herein above for improving the described project.
- IV. That the Village transmit to the Director of Transportation a fully executed copy of this Ordinance.


SECTION VI - Authority to Sign

The City Manager is hereby empowered on behalf of the Village of the City of Gallipolis to enter into contracts with the Director of Transportation necessary to complete the above described project.


SECTION VII - This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.


