AMENDING SECTION D5, WATER DISTRIBUTION/SEWER COLLECTION,
AND REPEALING PREVIOUS ORDINANCES SETTING SAID COMPENSATION**

WHEREAS, the City Commission of the City of Gallipolis, Ohio wishes to amend Ordinance No. O2010-77, as amended by Ordinance No. O2011-01, as amended by Ordinance No. O2011-79, as amended by Ordinance No. O2012-13, as amended by Ordinance No. O2012-66, as amended by Ordinance No. O2013-01, as amended by Ordinance No. O2013-21, as amended by Ordinance No. O2014-04, as amended by Ordinance No. O2014-20, as amended by Ordinance No. O2014-29, as amended by Ordinance No. O2014-38, to add compensation for Class II Sewer Collection License.

NOW, THEREFORE, BE IT ORDAINED, by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following be added to Section D5, Water Distribution/Sewer Collection:

(a) Maintenance employees who possess a valid Ohio EPA Water Distribution System Operator's License I or II or who possess a valid Ohio EPA Collection License I shall receive the following hourly amount to be added to their normal rate of pay:

- (1) \$.40 for Class I Water Distribution License
- (2) an additional \$.60 for Class II Water Distribution License
- (3) \$.60 for Class I Sewer Collection License
- (4) **an additional \$.80 for Class II Sewer Collection License**

Section 2: REPEAL OF PREVIOUS ORDINANCES

All previous ordinances setting compensation except Section 7 of Ordinance No. O2003-11 which Ordinance shall remain effective for all employees hired before September 30, 1981, with regard to their longevity increase.

Section 3: SAVINGS CLAUSE.




Section 4: EFFECTIVE DATE

This Ordinance shall be in full force and effect at the earliest period of time allowed by law.




