

**ORDINANCE NO. O2015-30**

**AN ORDINANCE TO REVISE THE  
CODIFIED ORDINANCES OF THE CITY OF GALLIPOLIS, OHIO  
BY ADOPTING CURRENT REPLACEMENT PAGES  
PURSUANT TO THE AGREEMENT WITH THE  
WALTER H. DRANE COMPANY**

**WHEREAS**, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

**WHEREAS**, various ordinances of a general and permanent nature have been passed by the City Commission which should be included in the Codified Ordinances; and

**WHEREAS**, the City heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before the Commission; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

**SECTION 1:** That the ordinances of the City of Gallipolis, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2015 Replacement Pages to the Codified Ordinances are hereby approved and adopted.
