

ORDINANCE NO. O2016-28

AN EMERGENCY ORDINANCE ACCEPTING AND REJECTING BIDS FOR
WATER/SEWER MAINTENANCE SUPPLIES, HYDRANTS AND METERS

Pursuant to Resolution No. R2015-14, passed by the City Commission on November 3, 2015, the City Manager advertised in the Gallipolis Daily Tribune, a newspaper of general circulation in the City of Gallipolis, Ohio, for Water/Sewer Maintenance Supplies, Hydrants and Meters.

The bids submitted were filed with the City Manager until 12:00 Noon, Friday, May 20, 2016, at which time they were duly opened and read. All of said bids are attached hereto and incorporated herein by reference.

WHEREAS, the bid of all four of the companies that submitted competitive bids are the lowest and most responsible for a portion of the supplies contained within the bid list; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio, that the bid of the companies listed in Section 1 are hereby declared the lowest and most responsible bids for certain water/sewer supplies, and the said as incorporated hereinabove is hereby accepted.

SECTION 1: That the following companies:

- (1) HD Supply, 3015 E 17th Avenue, Columbus, Ohio 43219;
- (2) The C. I. Thornburg Co., Inc., 4034 Altizer Avenue, Huntington, WV 25705;
- (3) Utility Sales Agency of America, 7272 Pleasant Plain Rd, Clayton, OH 45315;
- (4) Buckeye State Pipe & Supply, 14680 Pleasant Valley Rd, Chillicothe, OH 45601;

be awarded a contract for line items as per attached bid tabulation. The total contract amount is not to exceed budgetary funding.




SECTION 3: All other bids and parts of bids are hereby rejected.
