

**ORDINANCE NO. O2009-20**

**AN ORDINANCE ACCEPTING AND REJECTING BIDS FOR  
WATER/SEWER MAINTENANCE SUPPLIES, HYDRANTS AND METERS**

Pursuant to Resolution No. R2008-18, passed by the City Commission on November 18, 2008, the City Manager advertised in the Gallipolis Daily Tribune, a newspaper of general circulation in the City of Gallipolis, Ohio, for Water/Sewer Maintenance Supplies, Hydrants and Meters.

The bids submitted were filed with the City Manager until 12:00 Noon, Friday, March 27, 2009, at which time they were duly opened and read. All of said bids are attached hereto and incorporated herein by reference.

**WHEREAS**, the bids of six of the eight companies that submitted competitive bids are the lowest and most responsible for a portion of the supplies contained within the bid list.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio, that the bids of the companies listed in Section 1 are hereby declared the lowest and most responsible bids for certain water/sewer supplies, and the said as incorporated hereinabove are hereby accepted.

SECTION 1: That the following companies:

- (2) Consolidated Pipe & Supply Co., 77 Industrial Drive, Debord, KY 41214;

- (4) Ferguson Waterworks, 173 Enterprise Drive, Marietta, Ohio 45750;
- (5) Crescent & Sprague, 1100-12 E. Greene Street, P. O. Box 1027, Marietta, OH 45750;
- (6) Utility Service & Supply, Inc., 401 Lawton Avenue, P. O. Box 438, Monroe, OH 45050.

be awarded a contract for line items as per attached bid tabulation. The total contract amount is not to exceed budgetary funding.


