

ORDINANCE NO. O2009-24

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2009-08,
AS AMENDED BY ORDINANCE NO. O2009-12,
AS AMENDED BY ORDINANCE NO. O2009-13,
AS AMENDED BY ORDINANCE NO. O2009-16,
SETTING APPROPRIATIONS FOR THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2009

WHEREAS, it is necessary to amend Ordinance No. O2009-08, as amended by Ordinance No. O2009-12, as amended by Ordinance No. O2009-13, as amended by Ordinance No. O2009-16, to appropriate necessary funds for the CDBG Paving Project, the Canine Cop Fund and other funds; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following sections be amended to read as follows:

SECTION 11: 101.220 Police from \$922,308.00 to \$924,108.00

SECTION 12: 101.230 Fire from \$208,603.00 to \$209,753.00

SECTION 20: 101.920 Transfers/Advances from \$544,688.98 to \$555,305.48

SECTION 22: TOTAL GENERAL FUND from \$3,460,152.78 to \$3,473,719.28

SECTION 23: 211.381 Maintenance & Repair Streets from \$297,204.42 to \$307,420.92

SECTION 32: 266.581 Tax Increment Financing from \$277,020.45 to \$289,020.45

SECTION 37: 274.227 Canine Cop from \$2,950.00 to \$3,650.00

SECTION 47: TOTAL SPECIAL REVENUE FUNDS from \$1,782,802.78 to \$1,805,719.28

SECTION 50: 358.800 CDBG Paving from \$69,936.00 to \$80,152.50

SECTION 55: TOTAL CAPITAL PROJECTS FUNDS from \$1,793,412.47 to \$1,803,628.97

SECTION 64: 530.510 Rinky Dink Basketball from \$18,012.63 to \$18,380.13

SECTION 83: TOTAL ENTERPRISE FUNDS from \$3,891,945.21 to \$3,892,312.71

SECTION 89: TOTAL ALL FUNDS from \$11,285,018.64 to \$11,332,085.64

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
