SETTING APPROPRIATIONS FOR THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2009

WHEREAS, it is necessary to amend Ordinance No. O2009-08, as amended by Ordinance No. O2009-12, as amended by Ordinance No. O2009-13, as amended by Ordinance No. O2009-16, as amended by Ordinance No. O2009-24, as amended by Ordinance No. O2009-26, as amended by Ordinance No. O2009-31, as amended by Ordinance No. O2009-34, as amended by Ordinance No. O2009-43, as amended by Ordinance No. O2009-44, to appropriate necessary funds; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following sections be amended to read as follows:

SECTION 5: 101.133 Taxation from \$141,909.00 to \$149,909.00

SECTION 12: 101.230 Fire from \$209,753.00 to \$211,233.00

SECTION 22: TOTAL GENERAL FUND from \$4,497,540.08 to \$4,507,020.08

SECTION 67: 551.352 Water Treatment Plant from \$507,905.42 to \$532,025.42

SECTION 71: TOTAL WATER FUND from \$1,898,685.33 to \$1,922,805.33

SECTION 83: TOTAL ENTERPRISE FUNDS from \$3,906,486.79 to \$3,930,606.79


SECTION 89: TOTAL ALL FUNDS from \$12,803,170.72 to \$12,836,770.72

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
