SETTING APPROPRIATIONS FOR THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2009**

WHEREAS, it is necessary to amend Ordinance No. O2009-08, as amended by Ordinance No. O2009-12, as amended by Ordinance No. O2009-13, as amended by Ordinance No. O2009-16, as amended by Ordinance No. O2009-24, as amended by Ordinance No. O2009-26, as amended by O2009-31, as amended by Ordinance No. O2009-34, as amended by Ordinance No. O2009-43, as amended by Ordinance No. O2009-44, as amended by Ordinance No. O2009-54, to appropriate necessary funds; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.


