

ORDINANCE NO. O2013-04

**AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING
THE CITY MANAGER TO AUTHORIZE AND FUND
CHANGE ORDER NUMBERS 2 AND 3 WITH HOON, INC.
FOR CONSTRUCTION OF THE NEW GALLIPOLIS MUNICIPAL BUILDING
FOR THE ADMINISTRATIVE OFFICES
FOR FIBER OPTIC CABLE WEATHER HEAD
AND GAS LINE RELOCATE**

WHEREAS, it is necessary to accept two change orders on the original contract for the construction of the new Gallipolis Municipal Building for the Administrative Offices; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

SECTION 1: That the City Manager is hereby authorized and directed to enter into the attached Change Order No. 2 for the additional amount of \$275.00 for to add 2" weather head for fiber optic cable and attached Change Order No. 3 for the additional amount of \$612.15 for gas line relocate.


SECTION 2: That the City Auditor is hereby authorized to draw her warrant for said Change Order No. 2 to Hoon, Inc., P. O. Box 804, Athens, OH 45701, for an amount not to exceed Two Hundred Seventy-five and 00/100 Dollars (\$275.00) at the direction of the City Manager, as per Change Order No. 2, which is attached hereto and made a part of this Ordinance as if fully written herein.

SECTION 3: That the City Auditor is hereby authorized to draw her warrant for said Change Order No. 3 to Hoon, Inc., P. O. Box 804, Athens, OH 45701, for an amount not to exceed Six Hundred Twelve and 15/100 Dollars (\$612.15) at the direction of the City Manager, as per Change Order No. 3, which is attached hereto and made a part of this Ordinance as if fully written herein.


SECTION 4: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.


