

ORDINANCE NO. O2013-15

**AN EMERGENCY ORDINANCE ACCEPTING AND REJECTING BIDS
FOR THE HEDGEWOOD DRIVE LANDSLIDE REPAIR PROJECT**

Pursuant to Resolution No. R2012-04, passed by the City Commission on March 6, 2012, the City Manager advertised in the Gallipolis Daily Tribune, a newspaper of general circulation in the City of Gallipolis, Ohio, for the Hedgewood Drive Landslide Repair Project.

The bids submitted were filed with the City Manager until 12:00 Noon, Tuesday, November 20, 2012, at which time no bids were received. The project was rebid and advertised in the Gallipolis Daily Tribune, a newspaper of general circulation in the City of Gallipolis, Ohio for the Hedgewood Drive Landslide Repair Project. Bids submitted were filed with the City Manager until 12:00 Noon, Friday, February 1, 2013. All of said bids are attached hereto and incorporated herein by reference.

WHEREAS, the bids are being evaluated and the City Commission desires to award the construction contract based upon the recommendation of the engineering consulting firm of E. L. Robinson, Ironton, Ohio, for the Hedgewood Drive Landslide Repair Project; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

SECTION 1: That the bid be awarded to the firm of Suburban Maintenance and Construction, Inc., 16330 York Road, North Royalton, Ohio 44133, as recommended by the consulting engineering firm of E. L. Robinson, for the Hedgewood Drive Landslide Repair Project, for 198 ft. with the cantilever design for \$180,000.00.

SECTION 2: That the City Auditor is authorized to draw her warrants on the City of Gallipolis, Ohio, payable to Suburban Maintenance and Construction, Inc., 16330 York Road, North Royalton, Ohio 44133, not to exceed the amount in their submitted bid for 198 ft. with the cantilever design for One Hundred Eighty Thousand and 00/100 Dollars (\$180,000.00).

SECTION 3: All other bids and parts of bids are hereby rejected.

SECTION 4: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
