

**ORDINANCE NO. O2013-17**

**AN EMERGENCY ORDINANCE AUTHORIZING THE CITY AUDITOR  
TO TRANSFER OR ADVANCE FUNDS**

**WHEREAS**, it is necessary to transfer funds or advance funds to pay for appropriations; and

**WHEREAS**, Ordinance No. O2013-16, the Appropriations Ordinance, provides for such funds to be transferred or advanced as needed throughout the year; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

**SECTION A:** That the City Auditor is hereby authorized to transfer funds as needed as follows:
