

ORDINANCE NO. O2013-30

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2013-16,
AS AMENDED BY ORDINANCE NO. O2013-23, SETTING APPROPRIATIONS
FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2013**

WHEREAS, it is necessary to amend Ordinance No. O2013-16, as amended by Ordinance No. O2013-23, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:


Section 1: That the following sections be amended to read as follows:


SECTION 17: 101.900 General Capital Improvements from \$30,375.00 to \$39,560.00

SECTION 26: 225.581 Fire Levy from \$124,557.64 to \$126,857.64
SECTION 36: 265.800 FEMA Disaster from \$1,053,862.00 to \$1,092,039.65
SECTION 55: TOTAL SPECIAL REVENUE FUNDS from \$2,851,261.94 to \$2,891,739.59
SECTION 62: 366.227 Court Capital Improvement Fund from \$265,374.19 to \$277,874.19
SECTION 65: TOTAL CAPITAL PROJECTS FUNDS from \$389,353.22 to \$401,853.22
SECTION 76: 551.351 Water Administration for \$386,338.97 to \$390,728.97
SECTION 80: TOTAL WATER FUND from \$1,667,153.08 to \$1,671,543.08
SECTION 81: 552.356 WPC Administration from \$322,678.86 to \$329,043.86
SECTION 84: 552.709 WPC Debt Service from \$332,800.67 to \$349,661.35
SECTION 85: TOTAL WPC FUND from \$1,437,085.81 to \$1,460,311.49
SECTION 92: TOTAL ENTERPRISE FUNDS from \$3,717,888.92 to \$3,745,504.60
SECTION 99: TOTAL ALL FUNDS from \$11,276,075.17 to \$11,365,853.50

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
