

**ORDINANCE NO. 2013-47**

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 2013-34,  
AUTHORIZING THE CITY MANAGER  
TO PURCHASE A 2007 ALTEC BUCKET TRUCK AND A 2013 VERMEER BRUSH  
CHIPPER FOR THE CITY OF GALLIPOLIS MAINTENANCE DEPARTMENTS AND  
TO ENTER INTO LEASE/PURCHASE AGREEMENT FOR SAID EQUIPMENT**

**WHEREAS**, the City of Gallipolis is desirous of purchasing a bucket truck and brush chipper needed for the maintenance departments of the City of Gallipolis; and

**WHEREAS**, quotes were solicited and Vermeer and Altec were selected as the lowest and most responsible quotes; and

**WHEREAS**, it was subsequently found that another bucket truck more closely met the needs of the City of Gallipolis; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio that Ordinance No. 2013-37, which reads as follows:

**SECTION 1:** That the City Manager of the City of Gallipolis is hereby authorized to purchase from Altec Nueco, 1730 Vanderbilt Road, Birmingham, Alabama 32534, and to enter into agreement to lease/purchase a 2007 International Altec Nueco Stk (Bucket Truck) for Thirty-Eight Thousand Nine Hundred and 00/100 Dollars.

**SECTION 2:** That the City Manager of the City of Gallipolis is hereby authorized to purchase from Vermeer, 2574 US Highway 22 NW, Washington, CH, OH 43160, and to enter into agreement to lease/purchase a 2013 Vermeer BC-1000 XL Brush Chipper for Twenty-three Thousand Eight Hundred and One and 00/100 Dollars.

**BE, AND HEREBY, IS AMENDED** to read as follows:

**SECTION 1:** That the City Manager of the City of Gallipolis is hereby authorized to purchase from Sunrise Equipment Company, 5075 Navarre Road, SW, Canton, OH 44706, and to enter into agreement to lease/purchase a 2007 Ford F450 Bucket Truck with Altec AT200A 35' Altec Bucket (VIN 1FDXF46Y97EB11799) for Forty-six Thousand and Seventy-five and 00/100 Dollars.


**SECTION 2:** That the City Manager of the City of Gallipolis is hereby authorized to purchase from Vermeer, 2574 US Highway 22 NW, Washington, CH, OH 43160, and to enter into agreement to lease/purchase a 2013 Vermeer BC-1000 XL Brush Chipper for Twenty-three Thousand Eight Hundred and One and 00/100 Dollars.


**SECTION 3:** That the City Auditor is hereby authorized to draw her warrants on the City not to exceed budgetary funding for the lease/purchase of a Bucket Truck and a Brush Chipper for the City of Gallipolis Maintenance Departments, at the direction of the City Manager as per Sections 1 and 2 of this Ordinance.

**SECTION 4:** This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.


