

**ORDINANCE NO. O2013-62**

**AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING  
THE CITY MANAGER TO ENTER INTO AGREEMENT  
WITH CT CONSULTANTS FOR AMENDMENT NO. 3  
FOR THE GALLIPOLIS WPCF HEADWORKS FACILITY IMPROVEMENTS**

**WHEREAS**, in accordance with the Agreement dated November 8, 2011 for Professional Services between The Floyd Browne Group, and later dba as CT Consultants, hereinafter referred to as "ENGINEER" and the City of Gallipolis, Ohio, hereinafter referred to as "CLIENT", this Amendment No. 3 shall modify the scope of service to be performed by ENGINEER and the fees to be paid by CLIENT to ENGINEER; and

**WHEREAS**, the existing Headworks equipment (comminutor and bar screens) at the Water Pollution Control Facility (WPCF) is aged and in poor condition; and

**WHEREAS**, the existing Headworks equipment does not remove manufactured inerts (rags, debris, etc.) sufficiently to protect downstream equipment in the WPCF, resulting in significant maintenance efforts; and

**WHEREAS**, regulations for land application of sludge enacted as of July, 2011 require fine screening of manufactured inerts at the WPCF by July 1, 2015; and

**WHEREAS**, the CLIENT has decided to proceed with the design and bidding of a new Headworks Facility with fine screens at the WPCF concurrently with the Study and Report Phase and ahead of the design of other improvements at the WPCF; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:


**SECTION 1:** That the City Manager is hereby authorized and directed to enter into the attached Amendment No. 3 to change the scope of the work for the additional amount of \$94,300.00 to the base bid for the WPCF improvements.


**SECTION 2:** That the City Auditor is hereby authorized to draw her warrant for said Amendment No. 3 to CT Consultants, 7965 North High Street, Suite 340, Columbus, Ohio 43235, for an amount not to exceed Nine Hundred Fifty-two Thousand Seven Hundred and 00/100 Dollars (\$952,700.00) to change the scope of work as per Amendment No. 3, which is attached hereto and made a part of this Ordinance as if fully written herein. Total contract amount to be adjusted to a total lump sum not to exceed One Million One Hundred Twenty-three Thousand Dollars (\$1,123,000.00).

**SECTION 3:** This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
