

**ORDINANCE NO. O2014-12**

**AN ORDINANCE AMENDING ORDINANCE NO. O2010-77,  
AS AMENDED BY ORDINANCE NO. O2011-01,  
AS AMENDED BY ORDINANCE NO. O2011-79,  
AS AMENDED BY ORDINANCE NO. O2012-66,  
AS AMENDED BY ORDINANCE NO. O2013-21,  
AMENDING C6(c), COMPENSATION FOR SALARIED EMPLOYEES,  
ASSISTANT VOLUNTEER FIRE CHIEF  
AND REPEALING PREVIOUS ORDINANCES SETTING SAID COMPENSATION**

WHEREAS, the City Commission of the City of Gallipolis, Ohio wishes to amend Ordinance No. O2010-77, as amended by Ordinance No. O2011-01, as amended by Ordinance No. O2011-79, as amended by Ordinance No. O2012-66, as amended by Ordinance No. O2013-21, to change the compensation set for the Assistant Volunteer Fire Chief.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: **That SECTION C6: COMPENSATION FOR SALARIED EMPLOYEES, (c)**, setting compensation for Assistant Volunteer Fire Chief, which reads as follows:

(c) The Assistant Volunteer Fire Chief will receive One Thousand Eight Hundred Dollars (1,800) yearly compensation to be paid semi-annually effective November 29, 2010.

**BE, AND HEREBY IS, AMENDED** to read as follows for compensation for Assistant Volunteer Fire Chief:

(c) The Assistant Volunteer Fire Chief will not be compensated.

Section 2: REPEAL OF PREVIOUS ORDINANCES

All previous ordinances setting compensation for Assistant Volunteer Fire Chief, except Section 7 of Ordinance No. O2003-11 which Ordinance shall remain effective for all employees hired before September 30, 1981, with regard to their longevity increase.

Section 3: SAVINGS CLAUSE.


That nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section E of Ordinance No. 2010-77, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.


Section 4: EFFECTIVE DATE
