

**ORDINANCE NO. O2014-17**

**AN EMERGENCY ORDINANCE AMENDING  
ORDINANCE NO. O2011-81, SECTION 2,  
AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENT  
WITH THE LOCAL GOVERNMENT SERVICES SECTION  
OF THE STATE AUDITOR'S OFFICE  
(GASB-34 LOOK-ALIKE STATEMENTS)  
FOR FISCAL YEARS 2011, 2012 AND 2013**

**WHEREAS**, the City Commission of the City of Gallipolis, Ohio wishes to amend Ordinance O2011-81 to change compensation to the State Auditor's Office for services for the conversion of the financial statements for the fiscal year 2013 per the attached letter dated March 20, 2014; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety, and property and in order to provide for the usual operations of the municipal departments; and

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio,

**SECTION 1:** That SECTION 2 which reads as follows:

**SECTION 2:** The City Auditor is authorized at the direction of the City Manager to draw her warrants payable to the State Auditor's Office for an amount not to exceed Four Thousand Five Hundred and 00/100 Dollars (\$4,500.00) for FY 2011, and Seven Thousand Two Hundred Fifty and 00/100 Dollars (\$7,250.00) for FY 2012 and Four Thousand and 00/100 Dollars (\$4,000.00) for FY 2013.


**BE, AND HEREBY IS AMENDED**, to read as follows:


**SECTION 2:** The City Auditor is authorized at the direction of the City Manager to draw her warrants payable to the State Auditor's Office for an amount not to exceed Four Thousand Five Hundred and 00/100 Dollars (\$4,500.00) for FY 2011, and Seven Thousand Two Hundred Fifty and 00/100 Dollars (\$7,250.00) for FY 2012 and Seven Thousand and 00/100 Dollars (\$7,000.00) for FY 2013.

**SECTION 2:** This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.




