**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2010-77,
AS AMENDED BY ORDINANCE NO. O2011-01,
AS AMENDED BY ORDINANCE NO. O2011-79,
AS AMENDED BY ORDINANCE NO. O2013-21,
AS AMENDED BY ORDINANCE NO. O2014-04,
AS AMENDED BY ORDINANCE NO. O2014-20,
AMENDING D2(B), POSITIONS AND SALARY RANGES,
MAINTENANCE EMPLOYEES,
AND REPEALING PREVIOUS ORDINANCES SETTING SAID COMPENSATION**

WHEREAS, the City Commission of the City of Gallipolis, Ohio wishes to amend Ordinance No. O2010-77, as amended by Ordinance No. O2011-01, as amended by Ordinance No. O2011-79, as amended by Ordinance No. O2013-21, as amended by Ordinance No. O2014-04, as amended by Ordinance No. O2014-20, to change the salary range for Mechanic – ASE Certified/Crew Leader; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED, by the City Commission of the City of Gallipolis, State of Ohio:

Section 2: REPEAL OF PREVIOUS ORDINANCES

All previous ordinances setting compensation for Mechanic – ASE Certified/Crew Leader except Section 7 of Ordinance No. O2003-11 which Ordinance shall remain effective for all employees hired before September 30, 1981, with regard to their longevity increase.

That nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section E of Ordinance No. 2010-77, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

Section 4: EFFECTIVE DATE

This Ordinance shall be in full force and effect upon passage as an emergency measure.
