AMENDING SECTION A2, COMPENSATION FOR APPOINTED OFFICIALS,  
AND REPEALING PREVIOUS ORDINANCES SETTING SAID COMPENSATION**

**WHEREAS**, the City Commission of the City of Gallipolis, Ohio wishes to amend Ordinance No. O2010-77, as amended by Ordinance No. O2011-01, as amended by Ordinance No. O2011-79, as amended by Ordinance No. O2012-13, as amended by Ordinance No. O2012-66, as amended by Ordinance No. O2013-01, as amended by Ordinance No. O2013-21, as amended by Ordinance No. O2014-04, as amended by Ordinance No. O2014-20, as amended by Ordinance No. O2014-29, as amended by Ordinance No. O2014-38, as amended by Ordinance No. O2014-41, to set compensation for the City Manager; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following section which reads as follows:

SECTION A2: (a) That effective November 29, 2010, the City Manager of the City of Gallipolis, Ohio, shall receive as compensation the sum of Sixty-one Thousand Two Hundred Dollars (\$61,200) annually, payable biweekly.

(b) That the City Manager shall have four (4) weeks vacation per year beginning the effective date of his employment.

**BE, AND HEREBY IS AMENDED**, to read as follows:

SECTION A2: (a) That the City Manager of the City of Gallipolis, Ohio, shall receive as compensation the sum of Fifty-two Thousand Dollars (\$52,000) annually, payable biweekly (50% of his salary shall be paid from City Manager and 50% from Project Coordinator).

Section 2: REPEAL OF PREVIOUS ORDINANCES

All previous ordinances setting compensation except Section 7 of Ordinance No. O2003-11 which Ordinance shall remain effective for all employees hired before September 30, 1981, with regard to their longevity increase.

Section 3: SAVINGS CLAUSE.


That nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section E of Ordinance No. 2010-77, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.


Section 4: EFFECTIVE DATE

This Ordinance shall be in full force and effect upon passage as an emergency measure and retroactive to October 13, 2014.




