SETTING APPROPRIATIONS
FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2014**

WHEREAS, it is necessary to amend Ordinance No. O2014-13, as amended by Ordinance No. O2014-19, as amended by Ordinance No. O2014-24, as amended by Ordinance No. O2014-30, as amended by Ordinance No. O2014-37, as amended by Ordinance No. O2014-47, as amended by Ordinance No. O2014-56, as amended by Ordinance No. O2014-59, as amended by Ordinance No. O2014-72, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following sections be amended to read as follows:

SECTION 28:	249.541 Gallipolis In Lights from \$32,000.00 to \$37,000.00
SECTION 39:	269.800 Assistance to Firefighters Grant from \$0.00 to \$23,393.55
SECTION 52:	285.227 Court Probation Services from \$132,373.10 to \$112,023.73
SECTION 56:	TOTAL SPECIAL REVENUE FUNDS from \$1,880,784.35 to \$1,888,828.53
SECTION 61:	352.800 OPWC Water/Sewer Projects from \$8,413,880.67 to \$1,992,671.15
SECTION 66:	TOTAL CAPITAL PROJECTS FUND from \$8,767,334.10 to \$2,346,124.58
SECTION 99:	TOTAL ALL FUND from \$18,768,276.37 to \$12,355,111.03

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
