EXPRESSING THE APPRECIATION OF THE GALLIPOLIS CITY COMMISSION TO
DOW W. SAUNDERS

FOR OUTSTANDING SERVICES RENDERED AS
PRESIDENT, VICE-PRESIDENT AND MEMBER OF THE
CITY COMMISSION OF THE CITY OF GALLIPOLIS, OHIO,
AND EXTENDING THE BEST WISHES OF THE COMMUNITY TO HIM

WHEREAS, **Dow W. Saunders**, was appointed by the Gallipolis City Commission to fill a vacated seat of a Gallipolis City Commission member on April 3, 2003 until the end of the term ending December 31, 2005, and also served an additional four-year term ending December 31, 2009; and served as President from January 2, 2004 until December 31, 2007; and

WHEREAS, **Dow W. Saunders** previously served two-four-year terms with the Gallipolis City Commission as a member on January 1, 1994, served as Vice-President from June 3, 1997 until January 2, 1998 when he was elected President and served as President until his resignation on February 15, 2000; and

WHEREAS, **Dow W. Saunders** also previously served two four-year terms on the Commission from January 1984 until December 1991; serving the first two years as a member, the second two years as Vice-President and the second four-year term as President; and

WHEREAS, **Dow W. Saunders** served on various City and community boards during his tenure; and

WHEREAS, **Dow W. Saunders**, graduated from Gallia Academy High School and Rio Grande College in 1978, completed his masters of Social Work from Ohio State University in 1992, and is currently Director of Social Work at Holzer Medical Center; and

WHEREAS, and during the years of service of **Dow W. Saunders** many major improvements become a reality and the groundwork was laid for several projects; and

WHEREAS, **Dow W. Saunders** is well known throughout the community as an outstanding citizen and is to be commended for the many, many long hours of service he donated to the City of Gallipolis.

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Gallipolis, State of Ohio:

SECTION 1: That the Commission of the City of Gallipolis, Ohio, does hereby acknowledge the knowledge and experience, conscientious efforts and unwavering dedication rendered to this community by **Dow W.
