

ORDINANCE NO. O2017-30

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2017-06,
AS AMENDED BY ORDINANCE NO. O2017-13,
AS AMENDED BY ORDINANCE NO. O2017-22,
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2017**

WHEREAS, it is necessary to amend Ordinance No. O2017-06, as amended by Ordinance No. O2017-13, as amended by Ordinance No. O2017-22, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.


Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.


