SETTING APPROPRIATIONS FOR THE CITY OF GALLIPOLIS, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2009**

WHEREAS, it is necessary to amend Ordinance No. O2009-08, as amended by Ordinance No. O2009-12, as amended by Ordinance No. O2009-13, as amended by Ordinance No. O2009-16, as amended by Ordinance No. O2009-24, as amended by Ordinance No. O2009-26, as amended by Ordinance No. O2009-31, as amended by Ordinance No. O2009-34, as amended by Ordinance No. O2009-43, to appropriate necessary funds for new personnel positions; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That the following sections be amended to read as follows:

SECTION 2: 101.111 Municipal Court from \$327,933.00 to \$335,591.00

SECTION 10: 101.192 Code Enforcement from \$109,004.00 to \$115,034.00

SECTION 16: 101.530 Parks from \$112,033.00 to \$110,547.80

SECTION 22: TOTAL GENERAL FUND from \$4,485,337.28 to \$4,497,540.08

SECTION 73: 552.357 WPC Facility from \$545,817.12 to \$547,682.20

SECTION 74: 552.358 WPC Line Maintenance from \$281,113.01 to \$293,172.01

SECTION 77: TOTAL WPC FUND from \$1,433,396.65 to \$1,447,320.73

SECTION 83: TOTAL ENTERPRISE FUNDS from \$3,892,562.71 to \$3,906,486.79

SECTION 89: TOTAL ALL FUNDS from \$12,777,043.84 to \$12,803,170.72

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
