The City Manager reported on the following:

- A representative from PEP was here on January 24<sup>th</sup> and 25<sup>th</sup> to complete their risk assessment.
  Visits were made to the maintenance garage, water plant, wastewater plant, police, and fire department. The visit was very insightful and an action plan was put into place to make corrections.

- Congratulated Mr. Keith Elliott and the Fire Department on receiving a \$46,000 MARCS radio grant.
- Will meet tomorrow with Ms. Bryn Stepp, regional liaison with Governor Husted's office.
- Restorative work is being completed by the gas company on driveways and sidewalks.
- Great Lakes Community Action will be here on February 8<sup>th</sup> to begin the water/sewer line mapping project.
- Presented a handout to the commission that showed ratios of water loss and compared water billed to sewer gallons treated.
