

ORDINANCE NO. O2022-06

**AN ORDINANCE AUTHORIZING THE CITY AUDITOR
TO TRANSFER OR ADVANCE FUNDS**

WHEREAS, it is necessary to transfer funds or advance funds to pay for appropriations; and

WHEREAS, Ordinance No. O2022-05, the Appropriations Ordinance, provides for such funds to be transferred or advanced as needed throughout the year.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

SECTION A: That the City Auditor is hereby authorized to transfer funds as needed as follows:

- Section 1: \$65,000.00 from General 101.920.59111 to Cemeteries 242.49100

- Section 10: \$444.40 from FEMA 265.800.59107 to Court Capital Improvements 366.49105
- Section 11: \$6,000.00 from Court Probation Services 285.227.59100 to Community Corrections Act 272.49100
- Section 12: \$50,000.00 from Court Capital Improvement 366.227.59100 to Debt Service (Justice Center) 443.49314
- Section 13: \$50,000.00 from Water 551.351.59100 to Water Replacement and Improvement 560.49100
- Section 14: \$50,000.00 from Water 551.351.59101 to Water Capital Reserve 563.49100
- Section 15: \$30,000.00 from WPC 552.356.59100 to WPC Replacement and Improvement 561.49100
- Section 16: \$2,326.57 from Unclaimed Monies 776.521.59100 to General 101.49100

SECTION B: The City Auditor is authorized to advance funds as necessary as follows:

Section 1: \$34,262.11 from General 101.920.59129 to ODNR Natureworks Grant 280.49101

Section 2: \$40,000.00 from General 101.920.59150 to Capital Improvement Reserve 331.49101

Section 3: \$34,262.11 from ODNR Natureworks Grant 280.800.59101 to General 101.49101


Section 4: \$40,000.00 from Capital Improvement Reserve 331.970.59101 to General 101.49101

Section 5: \$23,000.00 from OPWC Repaving 351.800.59100 to General 101.49101


SECTION C: This Ordinance shall be in full force and effect at the earliest time allowed by law.
