

**ORDINANCE NO. O2019-11**

**AN ORDINANCE AMENDING ORDINANCE NO. O2019-06,  
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF  
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019**

**WHEREAS**, it is necessary to amend Ordinance No. O2019-06, to change appropriation sums in various accounts.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

  - SECTION 62: 551.353 Water Line Maintenance from \$451,062.42 to \$471,770.42
  - SECTION 64: TOTAL WATER FUND from \$1,562,436.13 to \$1,586,280.13
  - SECTION 65: 552.356 WPC Administration from \$248,189.20 to \$249,954.20
  - SECTION 67: 552.358 WPC Line Maintenance from \$402,992.22 to \$423,700.22
  - SECTION 69: TOTAL WPC FUND from \$1,773,156.88 to \$1,795,629.88
