SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF  
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019**

**WHEREAS**, it is necessary to amend Ordinance No. O2019-06, as amended by Ordinance No. O2019-11, as amended by Ordinance No. O2019-13, as amended by Ordinance No. O2019-15, as amended by Ordinance No. O2019-19, as amended by Ordinance No. O2019-21, as amended by Ordinance No. 2019-29, as amended by Ordinance No. 2019-31, as amended by Ordinance No. 2019-42, to change appropriation sums in various accounts; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

  - SECTION 58: TOTAL DEBT SERVICE FUND from \$288,341.42 to \$438,341.42
  - SECTION 62: 551.353 Water Line Maintenance from \$536,161.42 to \$544,356.42
  - SECTION 64: TOTAL WATER FUND from \$1,654,771.13 to \$1,662,966.13
  - SECTION 67: 552.358 WPC Line Maintenance from \$435,932.22 to \$438,688.72
  - SECTION 69: TOTAL WPC FUND from \$1,810,511.88 to \$1,813,268.38
