

ORDINANCE NO. O2020-24

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2020-06, AS AMENDED BY O2020-11, AS AMENDED BY ORDINANCE NO. O2020-12, AS AMENDED BY ORDINANCE NO. O2020-20, SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2020

WHEREAS, it is necessary to amend Ordinance No. O2020-06, as amended by Ordinance No. O2020-11, as amended by Ordinance No. O2020-12, as amended by Ordinance No. O2020-20 to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety, and property and in order to provide for the usual operations of the municipal departments

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

- Section 1:** That the following sections be repealed and amended to read as follows:
- SECTION 11: 101.230 Fire from \$210,224.04 to \$216,938.81
 - SECTION 21: TOTAL GENERAL FUND from \$3,233,203.01 to \$3,239,917.78
 - SECTION 22: 211.381 Maintenance & Repair Streets from \$276,112.19 to \$281,112.19.
 - SECTION 25B: 231.800 Cares Act Remote Tech Grant from \$0.00 to \$9,940.00.
 - SECTION 48: TOTAL SPECIAL REVENUE FUNDS from \$1,406,254.49 to \$1,421,194.49.
 - SECTION 62: 551.351 Water Administration from \$708,134.46 to \$716,134.46.
 - SECTION 66: TOTAL WATER FUND from \$2,027,427.27 to \$2,035,427.27.
 - SECTION 67: 552.356 WPC Administration from \$285,918.54 to \$293,918.54.
 - SECTION 71: TOTAL WPC FUND from \$2,064,009.39 to \$2,072,009.39.
 - SECTION 78: TOTAL ENTERPRISE FUNDS from \$5,004,238.80 to \$5,020,238.80.
 - SECTION 84: TOTAL ALL FUNDS from \$10,541,223.64 to \$10,578,878.41.

Section 2: This Ordinance shall be in full force and effect at the earliest time allowed by law.
