## **ORDINANCE NO. 02020-56**

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 02020-06, AS AMENDED BY ORDINANCE NO. 02020-11, AS AMENDED BY ORDINANCE NO. 02020-12, AS AMENDED BY ORDINANCE NO. 02020-20, AS AMENDED BY ORDINANCE NO. 02020-33, AS AMENDED BY ORDINANCE NO. 02020-44, AS AMENDED BY ORDINANCE NO. 02020-40, AS AMENDED BY ORDINANCE NO. 2020-44 SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2020

WHEREAS, it is necessary to amend Ordinance No. O2020-06, as amended by Ordinance No. O2020-11, as amended by Ordinance No. O2020-12, as amended by Ordinance No. O2020-20 as amended by Ordinance No. O2020-24, as amended by Ordinance No. O2020-33, as amended by Ordinance No. O2020-40, as amended by Ordinance No. O2020-44 to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety, and property and in order to provide for the usual operations of the municipal departments

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

SECTION 21: TOTAL GENERAL FUND from \$3,006,204.52 to \$2,948,978.89.

SECTION 22: 211.381 Maintenance & Repair Streets from \$310,958.19 to \$307,338.32.

SECTION 25A: 230.800 Cares Act from \$278,085.05 to \$326,780.47.

SECTION 42: 280.800 ODNR Natureworks Grant from \$104,289.74 to \$0.00.

SECTION 47: 286.227 Court Mediation Program from \$33,401.96 to \$35,366.94. SECTION 48: TOTAL SPECIAL REVENUE FUNDS from \$1,688,783.86 to \$1,631,534.65.

SECTION 50: 351.800 OPWC Repaying from \$252,093.81 to \$266,554.14.

SECTION 53: TOTAL CAPITAL PROJ FUNDS from \$456,415.27 to \$470,875.60.

SECTION 73 559.590 Swimming Pool from \$26,151.40 to \$26,351.40.

SECTION 78: TOTAL ENTERPRISE FUNDS from \$5,038,610.02 to \$5,038,810.02.

SECTION 84: TOTAL ALL FUNDS from \$10,708,613.79 to \$10,608,799.28.

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
