

ORDINANCE NO. O2021-11

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2021-04, AS AMENDED BY O2021-07 SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021

WHEREAS, it is necessary to amend Ordinance No. O2021-04, as amended by O2021-07 to change appropriation sums in various accounts.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

 - SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,186,352.64 to \$1,195,012.50.
 - SECTION 64: 551.351 Water Administration from \$454,908.92 to \$494,908.92.
 - SECTION 66: 551.353 Water Line Maintenance from \$618,605.86 to \$668,605.86.
 - SECTION 68: TOTAL WATER FUND from \$2,140,089.99 to \$2,230,089.99.
 - SECTION 69: 552.356 WPC Administration from \$358,170.26 to \$358,770.26.
 - SECTION 71: 552.358 WPC Line Maintenance from \$615,836.39 to \$618,336.39.
 - SECTION 73: TOTAL WPC FUND from \$2,035,757.98 to \$2,038,857.98.
 - SECTION 77: 560.354 Water Replacement & Improvement from \$150,000.00 to \$210,000.00.
 - SECTION 78: 561.359 WPC Replacement & Improvement from \$31,000.00 to \$41,000.00.
 - SECTION 81: TOTAL ENTERPRISE FUNDS from \$4,890,982.33 to \$5,054,082.33.
 - SECTION 84: TOTAL ALL FUNDS from \$10,165,685.01 to \$10,354,622.47.

Section 2: This Ordinance shall be in full force and effect at the earliest time allowed by law.
