

**ORDINANCE NO. O2021-29**

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2021-04, AS AMENDED BY ORDINANCE NO. O2021-07, AS AMENDED BY ORDINANCE NO. O2021-11, AS AMENDED BY ORDINANCE NO. O2021-16, AS AMENDED BY ORDINANCE NO. O2021-23 SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021**

**WHEREAS**, it is necessary to amend Ordinance No. O2021-04, as amended by Ordinance No. O2021-07, as amended by Ordinance No. O2021-11, as amended by Ordinance No. O2021-16, as amended by Ordinance No. O2021-23 to change appropriation sums in various accounts.

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

  - SECTION 26A: 232.800 American Rescue Plan \$348,606.00 to \$186,247.39.
  - SECTION 33: 257.800 Ohio MAS Grant from \$28,461.32 to \$34,261.32.
  - SECTION 34: 258.800 Ohio JRI Grant from \$133,507.63 to \$143,007.63.
  - SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,631,266.90 to \$1,484,208.29.
  - SECTION 64: 551.351 Water Administration from \$494,908.92 to \$495,626.42.
  - SECTION 68: TOTAL WATER FUND from \$2,239,589.99 to \$2,240,307.49.
  - SECTION 69: 552.356 WPC Administration from \$367,470.26 to \$368,280.76.
  - SECTION 73: TOTAL WPC FUND from \$2,058,057.98 to \$2,058,868.48.
  - SECTION 78: 561.359 WPC Replacement & Improvement from \$41,000.00 to \$91,000.00.
  - SECTION 81: TOTAL ENTERPRISE FUNDS from \$5,082,782.33 to \$5,134,310.33.
  - SECTION 84: TOTAL ALL FUNDS from \$10,837,298.07 to \$10,717,283.56.


**Section 2:** This Ordinance shall be in full force and effect at the earliest time allowed by law.


