

ORDINANCE NO. 02021-32

**AN ORDINANCE AUTHORIZING AND DIRECTING
THE CITY MANAGER TO ENTER INTO CONTRACT
FOR HOSPITALIZATION, MEDICAL AND MAJOR
MEDICAL, DRUG AND DENTAL INSURANCE
COVERAGE FOR FULL-TIME EMPLOYEES AND
ELECTED AND APPOINTED OFFICIALS OF THE CITY
OF GALLIPOLIS, OHIO**

WHEREAS, the City of Gallipolis is desirous of providing Hospitalization, Medical and Major Medical, Drug and Dental Insurance Coverage for full-time employees and elected and appointed officials; and

WHEREAS, the City of Gallipolis has renewed said Hospitalization, Medical and Major Medical, Drug and Dental Insurance Coverage; and

WHEREAS, Medical Mutual of Ohio is the current carrier for said medical and dental insurance coverage.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio, that the City Manager is authorized to negotiate a contract through the Saunders Insurance Agency and Wiseman Insurance Agency for health insurance coverage with the Jefferson Health Plan and dental insurance with Medical Mutual.

The City Manager is authorized to enter into contract as follows:

Section 1: That Jefferson Health Plan insurance coverage quoted by the firms of Saunders Insurance Agency and Wiseman Insurance Agency will be awarded a contract for health insurance coverage for the current plan we are on with a 0% increase of current rates.

Section 2: That the City Auditor is authorized to draw her warrants on the City of Gallipolis, Ohio, payable to Jefferson Health Plan, c/o U.S. Bank Institutional Custody Service, 425 Walnut St., Cincinnati, Ohio 45202, for hospitalization, medical and major medical, drug and dental insurance coverage at the direction of the City Manager.

Section 3: That Medical Mutual insurance coverage quoted by the firms of Saunders Insurance Agency and Wiseman Insurance Agency will be awarded a contract for dental insurance coverage for the current plan we are on with a 0% decrease in current rates, cost to be paid wholly from payroll deductions for covered employees and remitted to Medical Mutual, P.O. Box 951922, Cleveland, Ohio 44193.

Section 4: This Ordinance shall be in full force and effect for the new health insurance policy coverage period from January 1, 2022 through December 31, 2022.
