**RESOLUTION NO. R2017-02**

**AN EMERGENCY RESOLUTION SUPPORTING THE COUNTY  
BUDGET COMMISSION'S ALTERNATIVE FORMULA  
FOR THE DISTRIBUTION OF THE LOCAL GOVERNMENT FUND  
AND THE LOCAL GOVERNMENT REVENUE ASSISTANCE FUND  
FOR 2018, 2019, 2020, 2021 AND 2022**

**WHEREAS**, the Ohio Revised Code provides two options, Statutory or Alternate, for distribution of Undivided Local Government Funds by the County Budget Commission; and

**WHEREAS**, the Gallia County Budget Commission has chosen to create an alternative formula for the distribution of the Local Government Fund and the Local Government Revenue Assistance Fund. Said alternative formula provides for the welfare and needs of all jurisdictions within the County; and

**WHEREAS**, the City Commission believes the Gallia County Budget Commission's alternative formula provides an equitable division of said funds; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Resolution as an emergency measure in order to provide for the preservation of the public peace, health, safety and property of the citizenry of the City of Gallipolis and the usual daily operations of municipal services.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Gallipolis, State of Ohio:

**SECTION 1:** The City of Gallipolis hereby adopts and approves the alternative formula for the distribution of the Local Government Fund and the Local Government Revenue Assistance Fund as proposed and adopted by the Gallia County Budget Commission for distribution in 2018, 2019, 2020, 2021 and 2022.

**SECTION 2:** The formula hereby adopted and approved is the following:

Pursuant to R.C. 5747.53 and R.C. 5747.63, each subdivision entitled to receive a share of the Undivided Local Government fund and the Local Government Revenue Assistance Fund shall receive for distribution in calendar year 2018, 2019, 2020, 2021 and 2022 the following amount of each such Fund, in accordance with the following formula:

(A) Gallia County, O. O. McIntyre Park District, the City of Gallipolis (Village), and the respective Townships and respective Municipal Corporations in Gallia County, each taken as a group, shall receive the following percentages of each such Fund:

Gallia County	42.00 percent
Park District	0.25 percent
Villages	35.00 percent (distributed equally among 6 Villages)
Townships	22.75 percent (distributed 13.75% equally among 15 Townships) (distributed a 4.5% on CY 2016 township mileage and 4.5% on township population per 2010 Census)

**\*\* note this excludes village population and streets**

(B) Each Township and each corporation shall then receive an equal share of each Fund to be distributed to its class of subdivisions.

(C) The villages agree to accept the 35% distribution to be equally split between all six villages.

(D) Should any village cease to exist during the five-year period, then the villages will redistribute the 35% equally among the remaining villages. The new redistribution will be effective the year, following the year the village ceases to exist.

(E) The townships agree to the following distribution of their 22.75%.

(a) 13.75% distributed equally between all 15 townships.

(b) 9% remaining distributed to 15 townships based on 4.5% mileage & 4.5% population (excluding village portions within the townships).

(F) Should any township cease to exist during the five-year period, then the townships will redistribute the 13.75% equally + 9% based on mileage + population among the remaining townships. The new redistribution will be effective the year, following the year the township ceases to exist along with a recalculation of the population and mileage part of the formula.

**SECTION 3:** That the Clerk of the City Commission is hereby directed to certify a copy of this Resolution to the Gallia County Auditor.

**SECTION 4:** This Resolution shall be in full force and effect immediately upon passage as an emergency measure.
