**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2016-12,
AS AMENDED BY ORDINANCE NO. O2016-18,
AS AMENDED BY ORDINANCE NO. O2016-24,
AS AMENDED BY ORDINANCE NO. O2016-34,
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016**

WHEREAS, it is necessary to amend Ordinance No. O2016-12, as amended by Ordinance No. O2016-18, as amended by Ordinance No. O2016-24, as amended by Ordinance No. O2016-34, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

- SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,228,303.69 to \$1,260,403.69
- SECTION 70: 551.351 Water Administration from \$550,766.94 to \$553,766.94
- SECTION 74: TOTAL WATER FUND from \$1,804,751.90 to \$1,807,751.90
- SECTION 75: 552.356 WPC Administration from \$586,734.22 to \$589,734.22
- SECTION 79: TOTAL WPC FUND from \$2,103,551.49 to \$2,106,551.49
- SECTION 80: 557.350 Sanitation from \$304,840.10 to \$314,840.10
