**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2016-12,  
AS AMENDED BY ORDINANCE NO. O2016-18,  
AS AMENDED BY ORDINANCE NO. O2016-24,  
AS AMENDED BY ORDINANCE NO. O2016-34,  
AS AMENDED BY ORDINANCE NO. O2016-36,  
AS AMENDED BY ORDINANCE NO. O2016-43,  
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF  
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016**

**WHEREAS**, it is necessary to amend Ordinance No. O2016-12, as amended by Ordinance No. O2016-18, as amended by Ordinance No. O2016-24, as amended by Ordinance No. O2016-34, as amended by Ordinance No. O2016-36, as amended by Ordinance No. O2016-43 to change appropriation sums in various accounts; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

**Section 1:** That the following sections be amended to read as follows:

- SECTION 16: 101.530 Parks from \$81,553.04 to \$81,053.04
- SECTION 22: TOTAL GENERAL FUND from \$3,096,744.53 to \$3,096,744.53
- SECTION 25: 220.990 VESI Community Reinvestment from \$13,288.25 to \$12,324.36
- SECTION 33: 257.800 Ohio MAS Grant from \$48,880.80 to \$47,380.80
- SECTION 35: 270.227 Law Enforcement Trust from \$36,051.46 to \$39,422.46
- SECTION 46: 285.227 Court Probation Services from \$106,187.26 to \$104,687.26
- SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,269,255.47 to \$1,268,662.58
- SECTION 56: 336.227 Court Capital Improvement from \$247,043.81 to \$264,386.34
- SECTION 59: TOTAL CAPITAL PROJECTS FUNDS from \$8,068,404.06 to \$8,085,746.59
- SECTION 93: TOTAL ALL FUNDS from \$18,840,994.83 to \$18,857,744.47

**Section 2:** This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
