

ORDINANCE NO. O2017-13

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2017-06,
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2017**

WHEREAS, it is necessary to amend Ordinance No. O2017-06, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

 - SECTION 46: TOTAL SPECIAL REVENUE FUNDS from \$1,080,802.76 to \$1,095,320.98
 - SECTION 62: 551.351 Water Administration from \$362,795.24 to \$442,795.24
 - SECTION 64: 551.353 Water Line Maintenance from \$426,250.60 to \$427,966.60
 - SECTION 66: TOTAL WATER FUND from \$1,382,493.53 to \$1,464,209.53
 - SECTION 67: 552.356 WPC Administration from \$238,763.54 to \$253,763.54
 - SECTION 69: 552.358 WPC Line Maintenance from \$360,132.60 to \$361,848.60
 - SECTION 71: TOTAL WPC FUND from \$1,655,460.80 to \$1,672,176.80
 - SECTION 78: TOTAL ENTERPRISE FUNDS from \$3,666,730.70 to \$3,765,162.70
 - SECTION 84: TOTAL ALL FUNDS from \$9,561,815.42 to \$9,675,764.29

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
