SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019**

WHEREAS, it is necessary to amend Ordinance No. O2019-06, as amended by Ordinance No. O2019-11, as amended by Ordinance No. O2019-13, as amended by Ordinance No. O2019-15, as amended by Ordinance No. O2019-19, as amended by Ordinance No, O2019-21, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

 - SECTION 48: TOTAL SPECIAL REVENUE FUNDS from \$1,282,332.34 to \$1,290,841.22
 - SECTION 50: 358.800 CDBG Paving from \$38,757.00 to \$37,053.50
 - SECTION 52: TOTAL CAPITAL PROJECTS FUNDS from \$215,593.46 to \$213,889.96
 - SECTION 60: 551.351 Water Administration from \$385,497.81 to \$386,997.81
 - SECTION 64: TOTAL WATER FUND from \$1,644,321.13 to \$1,645,821.13
 - SECTION 65: 552.356 WPC Administration from \$250,454.20 to \$251,454.20
 - SECTION 69: TOTAL WPC FUND from \$1,799,161.88 to \$1,800,161.88
 - SECTION 76: TOTAL ENTERPRISE FUNDS from \$4,347,019.84 to \$4,349,519.84
 - SECTION 82: TOTAL ALL FUNDS from \$9,596,909.21 to \$9,606,214.59

Section 2: This Ordinance shall be in full force and effect upon passage as an emergency measure.


