**SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF  
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019**

**WHEREAS**, it is necessary to amend Ordinance No. O2019-06, as amended by Ordinance No. O2019-11, as amended by Ordinance No. O2019-13, as amended by Ordinance No. O2019-15, as amended by Ordinance No. O2019-19, as amended by Ordinance No. O2019-21, as amended by Ordinance No. 2019-29, as amended by Ordinance No. 2019-31, as amended by Ordinance No. 2019-42, as amended by Ordinance No. O2019-49, to change appropriation sums in various accounts; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

- Section 1:** That the following sections be amended to read as follows:
- SECTION 3: 101.122 City Manager from \$104,898.34 to \$106,698.34
  - SECTION 4 101.131 City Auditor/Treasurer from \$137,300.45 to \$135,500.45
  - SECTION 20: TOTAL GENERAL FUND from \$3,651,552.16 to \$ 3,651,552.16
  - SECTION 26: 249.541 Gallipolis In Lights from \$102,054.18 to \$116,054.18
  - SECTION 45: 284.227 Court Computerization from \$26,463.65 to \$27,963.65
  - SECTION 48: TOTAL SPECIAL REVENUE FUNDS from \$1,285,198.38 to \$1,300,698.38
  - SECTION 82: TOTAL ALL FUNDS from \$10,094,948.25 to \$10,110,448.25

**Section 2:** This Ordinance shall be in full force and effect upon passage as an emergency measure
