

**ORDINANCE NO. O2020-15**

**AN EMERGENCY ORDINANCE ACCEPTING AND REJECTING BIDS FOR WATER/SEWER MAINTENANCE SUPPLIES, HYDRANTS AND METERS**

Pursuant to Resolution No. R2019-09, passed by the City Commission on November 19, 2019, the City Manager advertised in the Gallipolis Daily Tribune, a newspaper of general circulation in the City of Gallipolis, Ohio, for Water/Sewer Maintenance Supplies, Hydrants and Meters.

The bids submitted were filed with the City Manager until 12:00 Noon, Tuesday, May 5, 2020, at which time they were duly opened and read. All of said bids are attached hereto and incorporated herein by reference.

WHEREAS, the bid of all four of the companies that submitted competitive bids are the lowest and most responsible for a portion of the supplies contained within the bid list.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio, that the bid of the companies listed in Section 1 are hereby declared the lowest and most responsible bids for certain water/sewer supplies, and the said as incorporated hereinabove is hereby accepted.

SECTION 1: That the following companies:

- (1) Consolidated Pipe & Supply Co., 907 Honeybranch Industrial Park, Debord, KY 41214;
- (2) The C. I. Thornburg Co., Inc., 4034 Altizer Avenue, Huntington, WV 25705;
- (3) Buckeye State Pipe & Supply Co. Inc., 14680 Pleasant Valley Rd, Chillicothe, OH 45601;
- (4) Ferguson Waterworks, 3845 Groveport Road, Columbus, OH 43207;

be awarded a contract for line items as per attached bid tabulation. The total contract amount is not to exceed budgetary funding.

SECTION 2: The City Auditor is authorized to draw her warrants on the City of Gallipolis, Ohio, payable to Consolidated Pipe & Supply Co., The C. I. Thornburg Co., Inc., Buckeye State Pipe & Supply Co. Inc., and Ferguson Waterworks.

SECTION 3: All other bids and parts of bids are hereby rejected.
