ORDINANCE NO. O2021-16

AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2021-04, AS AMENDED BY O2021-07, AS AMENDED BY ORDINANCE NO. O2021-11 SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2021

WHEREAS, it is necessary to amend Ordinance No. O2021-04, as amended by Ordinance No. O2021-07, as amended by Ordinance No. O2021-11 to change appropriation sums in various accounts.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:


Section 1: That the following sections be amended to read as follows:

- SECTION 11: 101.230 Fire from \$244,664.20 to \$254,385.40.
- SECTION 21: TOTAL GENERAL FUND from \$3,363,949.63 to \$3,373,670.83.
- SECTION 22: 211.381 Maintenance & Repair Streets from \$314,130.55 to \$343,130.55.
- SECTION 25: 225.581 Fire Levy from \$97,217.05 to \$100,757.55.
- SECTION 26A: 232.800 American Rescue Plan from \$0.00 to \$348,606.00.
- SECTION 27: 242.445 Cemeteries from \$106,073.88 to \$108,073.88.
- SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,195,012.50 to \$1,578,159.00.
- SECTION 66: 551.353 Water Line Maintenance from \$668,605.86 to \$678,105.86.
- SECTION 68: TOTAL WATER FUND from \$2,230,089.99 to \$2,239,589.99.
- SECTION 71: 552.358 WPC Line Maintenance from \$618,336.39 to \$628,836.39.
- SECTION 73: TOTAL WPC FUND from \$2,038,857.98 to \$2,049,357.98.
- SECTION 81: TOTAL ENTERPRISE FUNDS from \$5,054,082.33 to \$5,074,082.33.
- SECTION 84: TOTAL ALL FUNDS from \$10,354,622.47 to \$10,767,490.17.


Section 2: This Ordinance shall be in full force and effect at the earliest time allowed by law.


