

ORDINANCE NO. O2016-18

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2016-12,
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2016**

WHEREAS, it is necessary to amend Ordinance No. O2016-12, to change appropriation sums in various accounts; and

WHEREAS, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, State of Ohio:

- Section 1:** That the following sections be amended to read as follows:

 - SECTION 22: TOTAL GENERAL FUND from \$2,939,950.20 to \$2,941,841.70
 - SECTION 38: 275.227 Police Special Equipment from \$0.00 to \$3,000.00
 - SECTION 50: TOTAL SPECIAL REVENUE FUNDS from \$1,210,835.53 to \$1,213,835.53
 - SECTION 56: 366.227 Court Capital Improvement from \$216,180.76 to \$243,180.76
 - SECTION 59: TOTAL CAPITAL PROJECTS FUNDS from \$7,036,491.01 to \$7,063,491.01
 - SECTION 70: 551.351 Water Administration from \$491,408.41 to \$491,894.66
 - SECTION 74: TOTAL WATER FUND from \$1,732,216.90 to \$1,732,703.15
 - SECTION 84: 562.355 Utility Depository from \$0.00 to \$8,000.00
 - SECTION 86: TOTAL ENTERPRISE FUNDS from \$4,484,855.13 to \$4,493,341.38
 - SECTION 93: TOTAL ALL FUNDS from \$16,371,960.23 to \$16,412,337.98

Section 2: This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
