

**ORDINANCE NO. O2017-15**

**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2014-71,  
AS AMENDED BY ORDINANCE NO. O2015-04,  
AS AMENDED BY ORDINANCE NO. O2015-23,  
AS AMENDED BY ORDINANCE NO. O2015-61,  
AS AMENDED BY ORDINANCE NO. O2016-29,  
AS AMENDED BY ORDINANCE NO. O2017-08,  
AMENDING SECTION A4, COMPENSATION FOR SALARIED EMPLOYEES, AND  
REPEALING PREVIOUS ORDINANCES SETTING SAID COMPENSATION**

**WHEREAS**, the City Commission of the City of Gallipolis, Ohio wishes to amend O2014-71, to set compensation for the Assistant City Solicitor; and

**NOW, THEREFORE, BE IT ORDAINED**, by the City Commission of the City of Gallipolis, State of Ohio:

Section 1: That Section A4 (a) which reads as follows be deleted from Section A:

**SECTION A: COMPENSATION FOR APPOINTED OFFICIALS AND CLERK OF MUNICIPAL COURT.**

**SECTION A4: (a)** That effective January 1, 2014, the Assistant City Solicitor of the City of Gallipolis shall receive as compensation the sum of Sixteen Thousand Three Hundred Eighty-Nine Dollars (\$16,389) annually, payable biweekly.

Section 2: That Section C2: **POSITION AND SALARY RANGES** be amended to establish Salary Range No. A32 to read as follows:

**Section 3: REPEAL OF PREVIOUS ORDINANCES**

All previous ordinances setting compensation except Section 7 of Ordinance No. O2003-11 which Ordinance shall remain effective for all employees hired before September 30, 1981, with regard to their longevity increase.

**Section 4: EFFECTIVE DATE**

This Ordinance shall be in full force and effect as an emergency and retroactive to April 24, 2017.
