

**ORDINANCE NO. O2017-17**

**AN EMERGENCY ORDINANCE AUTHORIZING AND DIRECTING  
THE CITY MANAGER TO ENTER INTO AGREEMENT  
WITH CT CONSULTANTS FOR AMENDMENT NO. 4  
FOR THE GALLIPOLIS WPCF HEADWORKS FACILITY AND  
WPCF IMPROVEMENTS**

**WHEREAS**, in accordance with the Agreement dated November 8, 2011 for Professional Services between The Floyd Browne Group, and later dba as CT Consultants, hereinafter referred to as "ENGINEER" and the City of Gallipolis, Ohio, hereinafter referred to as "CLIENT", this Amendment No. 4 shall modify the scope of service to be performed by ENGINEER and the fees to be paid by CLIENT to ENGINEER; and

**WHEREAS**, the CLIENT desires to upgrade or expand the Water Pollution Control Facility (WPCF) to meet regulatory requirements and future community needs (Project); and

**WHEREAS**, it is necessary to employ registered professional engineers to provide professional services in connection with the Project; and

**WHEREAS**, in Amendments No. 1, 2 & 3 the CLIENT authorized design, bidding, construction and post construction phase work for the Headworks Facility project and WPCF Improvement project; and

**WHEREAS**, the construction period was extended beyond eighteen (18) months through no fault of the ENGINEER or CLIENT; and

**WHEREAS**, the City Manager has recommended in writing the passage of this Ordinance as an emergency measure as it is necessary for the immediate preservation of the public peace, health, safety and property and in order to provide for the usual operations of the municipal departments.

**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

**SECTION 1:** That the City Manager is hereby authorized and directed to enter into the attached Amendment No. 4 to change the scope of the work for the additional amount of \$77,221.30 to the base bid for the WPCF improvements.

**SECTION 2:** That the City Auditor is hereby authorized to draw her warrant for said Amendment No. 4 to CT Consultants, 7965 North High Street, Suite 340, Columbus, Ohio 43235, for an amount not to exceed Seventy-seven Thousand, Two Hundred, Twenty-one and 30/100 Dollars (\$77,221.30) to change the scope of work as per Amendment No. 4, which is attached hereto and made a part of this Ordinance as if fully written herein. Total contract amount to be adjusted to a total lump sum not to exceed One Million Twenty-nine Thousand Nine Hundred Twenty-one and 30/100 Dollars (\$1,029,921.30).

**SECTION 3:** This Ordinance shall be in full force and effect immediately upon passage as an emergency measure.
