**AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. O2017-06,  
AS AMENDED BY ORDINANCE NO. O2017-13,  
AS AMENDED BY ORDINANCE NO. O2017-22,  
AS AMENDED BY ORDINANCE NO. O2017-30,  
SETTING APPROPRIATIONS FOR CURRENT EXPENSES OF THE CITY OF  
GALLIPOLIS, OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2017**

**WHEREAS**, it is necessary to amend Ordinance No. O2017-06, as amended by Ordinance No. O2017-13, as amended by Ordinance No. O2017-22, as amended by Ordinance No. O2017-30, to change appropriation sums in various accounts; and




**NOW, THEREFORE, BE IT ORDAINED** by the City Commission of the City of Gallipolis, State of Ohio:

- Section 1:** That the following sections be amended to read as follows:

  - SECTION 28: 251.541 City Park Tree Fund from \$4,215.00 to \$4,750.00
  - SECTION 34: 272.800 Community Corrections Act from \$46,164.80 to \$39,031.27
  - SECTION 42: 283.995 Alcohol Treatment from \$5,002.48 to \$8,002.48
  - SECTION 46: TOTAL SPECIAL REVENUE FUNDS from \$1,185,593.46 to \$1,181,994.93
  - SECTION 73: 559.590 Swimming Pool from \$59,757.00 to \$60,057.00
  - SECTION 78: TOTAL ENTERPRISE FUNDS from \$3,898,325.64 to \$3,898,625.64
  - SECTION 81: 776.521 Unclaimed Funds from \$2,539.78 to \$6,539.78
  - SECTION 83: TOTAL FIDUCIARY FUNDS from \$82,539.78 to \$86,539.78
  - SECTION 84: TOTAL ALL FUNDS from \$9,934,926.91 to \$9,934,628.38
