

ORDINANCE NO. 2023-17

AN EMERGENCY ORDINANCE AUTHORIZING MASTER AGREEMENT WITH ARCHER ENERGY, FOR THE SUPPLY OF NATURAL GAS AS RECOMMENDED BY TREBEL ENERGY

WHEREAS, the City of Gallipolis has an agreement with Trebel Energy for natural gas brokerage services and;

WHEREAS, Trebel assisted the city with development of a new Plan of Operation and Governance and recently obtained state PUCO certification for the City of Gallipolis residential and commercial accounts the City of Gallipolis; and

WHEREAS, Trebel Energy has continued to monitor natural gas prices and has recommended the City of Gallipolis enter into agreement with Archer Energy, LLC; and


WHEREAS, Archer Energy, LLC is certified by the Public Utilities Commission of Ohio as a Competitive Retail Natural Gas service provider to sell competitive retail natural gas and related services to customers and Governmental Aggregation programs in the State of Ohio within the service territory of Columbia Gas of Ohio and enrolled in the City's Governmental Aggregation program, and

WHEREAS, Archer Energy, LLC offered via Trebel Energy a fixed rate of \$0.595 per Ccf effective July 1, 2023-June 30, 2025 to become effective with agreement date of April 19, 2023, and

WHEREAS, Archer Energy will be notifying residential and commercial account of the service agreement dates, fixed price and opt-in and opt-out information, and **WHEREAS**, the City Commission approves of this master agreement with Archer Energy as recommended to the City by Trebel Energy for a two-year contract period for the Gas Aggregation Program.


