

ORDINANCE NO. O2025-23

AN ORDINANCE DIRECTING THE GALLIA COUNTY BOARD OF ELECTIONS TO PLACE ON THE BALLOT FOR NOVEMBER 4, 2025, THE ISSUE OF .5% LEVY ON INCOME FOR THE PURPOSE OF STREET PAVING AND POLICE AND CEMETERY DEPARTMENTS OPERATIONS FOR THE CITY OF GALLIPOLIS, OHIO

WHEREAS, the City of Gallipolis is desirous of promoting the health and welfare of the Citizenry by means of repairing and paving City streets, providing public safety operations by its Police Department, and the daily operation and maintenance of the Pine Street and Mound Hill Cemeteries; and

WHEREAS, due to a decrease in funding from revenue streams collected by the State of Ohio and distributed to the City, as well as other decreases in funding, this .05% income tax to be effective January 1, 2026, is necessary to the continued operation of the City in the areas listed above; and

WHEREAS, the tax is an annual tax levied on the income of every person residing in or earning or receiving income in the municipal corporation, and the tax shall be measured by municipal taxable income; and

WHEREAS, the City of Gallipolis is levying the tax in accordance with the limitations specified in Chapter 718.04 of the Revised Code, and the provisions of said chapter are incorporated herein by reference as if fully rewritten; and

WHEREAS, no credit shall be created as described in R.C. 718.04(D); and

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Gallipolis, Ohio:

SECTION 1: The City Clerk is hereby directed to forward this ordinance to the Gallia County Board of Elections.

SECTION 2: The Board of Elections is directed to place upon the ballot for November 4, 2025, the following language pursuant to Ohio Revised Code Section 718.04(c):
